If breathing has stopped, give artificial respiration. Get medical attention. 皮肤接触 Skin Contact: 以大量清水或肥皂水洗清. 脱掉严重污染的衣服, 鞋. 在再穿之前洗净, 如果刺激持续, 请就医. Flush with large amount of water; Use soap if available. Remove grossly contaminated clothing, including shoes and launder before re-use. Discard shoes. If irritation persists, get medical attention. 眼睛接触 Eye Contact: 立即翻起上下眼睑以大量水冲洗 15 分以上, 并及时送医治疗.
